ENGINEERS REPORT

Hill waterline: The disinfection process for the newly installed water has begun. There is only 1 service line remaining to be installed.

Mt. Pleasant Hoe Company ADA Access Path: The contractor has completed the project and submitted their final Application for payment No.3 and change order for No.2 for \$650.00 for the installation of the channel drain. The township approved the change order. A Motion was made to pay the contractor Bill Davis \$20,629.79 by Sterling second by Carr.

Hill Cul-De-Sac . Benesch has completed the project plan set for bidding Documents. Bids will be advertised July 14, 2014 July 23, 2014. A prebid meeting will be scheduled for July 30, 2014.
