ENGINEER REPORT

DCNR GRANT>>>>Benesch is in the beginning stages of the design phase of the playground project and will keep the township informed once significant progress has been made on the project.

PA Statewide Local Share Grant>>>>the grants are currently under review and are anticipated to be awarded in September 2024.

SALDO ZONING and stormwater Ordinance Updates>>>>Solicitor Brennan is working through advertising and scheduling the public hearing as requires for the SALDO.

A stand-Alone Timber Ordinance, based on the Penn State Model Ordinance is being developed by Solicitor Brennan.

CRG Reading Anthracite Company>>>>The Engineers for the CRG Reading have been ion discussion with the township Engineer and Solicitor to discuss the comments that were provided on November 14, 2023. They are working to address the comments and issues and have requested an extension till November with further extension possible.

Sanik Solar-Airport Road>>> The Engineers for the Sanik Solar Development are working to address the comments and issues.

Grant Opportunities>>>> The DCNR grants are currently under review and are anticipated to be awarded later this year.

Action items>>. The township should decide if they would like to apply for a PA Statewide Local Share Account Grant. Applications for the Grant are due on November 30th, 2024.
